MT Privacy Notice

What information do we collect?

- Home address

The following information is collected from you when entering competitions via Facebook. This information may include:

• Your name

Why are we collecting this information?

This information is being collected so that we may contact you should be selected as a winner of the competition.

Do we share your information?

We may have to share your personal data with:

- Approved third parties who provide us with services to enable us to deliver services to you.
- Regulators and other authorities for the purposes of prevention, detection and prosecution of criminal offences or issues relating to national security or, where we are required to do so in the event of a national emergency to comply with other legal or regulatory requirements.

Some external third parties (for example our suppliers) are based or have offices outside the European Economic Area ('EEA'); if they process your data as part of our relationship with them, it may mean that your personal data is transferred outside the EEA. Where this occurs, we will ensure that an adequate level of protection is applied in accordance with the Data Protection Laws.



How long do we retain your information?

We will ensure personal data will not be kept for longer than is necessary. Any data collected as part of this competition will be erased following the closure of the competition, no later than 31 July 2024 unless you have Opted In on your Marketing preferences.

Your rights as a data subject

You have the right to request a copy of the information held about you. If this information is incorrect, or you wish to have it removed, you have the right as an individual to request it to be rectified or erased. We will verify your identity prior to a request being actioned.

If you object to the processing or feel that the personal information retained by us is inaccurate or is being unlawfully processed, please inform us and we will restrict the processing until the matter has been investigated and corrected.
